SUMMARY of LATE ITEMS

5.1 25/00457/FUL 79 Peveril Road Beeston

There are no late items to report

5.2 25/00540/FUL Land North of 25 Nether Green Eastwood

Since the publication of the agenda the applicant has submitted a speed survey and amended visibility splay details. These have been checked by Nottinghamshire County Council Highways Authority and have stated in response:

As the applicant has stated the south bound speeds are 34.6 (35mph) which will require 2.4m x 60m visibility splay.

North bound speeds are 36.7 (37mph) which will require 2.4m x 65m visibility splay.

The submitted amended visibility splay shows 100m to the south and north but the Highways Authority wishes that the visibility splay is clear of any obstructions within the highway and the applicants own land (not third part land). This includes walls/fences to be set back from the highway to ensure no obstruction of the visibility splays. The plan submitted does not demonstrate the visibility splay is clear of any obstructions but this could be conditioned.
