**NOTE: "Land" includes an easement, servitude, interest or right in or over land which does not carry with it a right for you, your spouse or civil partner (alone or jointly with another) to occupy the land or to receive income.**

**NOTE: you only need to register land in the Council's area. This includes your home if you own it or rent it.**

**5. Address or other description of any land in the Council's area for which I and / or my spouse or civil partner has a licence (alone or jointly with others) to occupy for a month or longer.**

**6. Address or other description of any land where the landlord is the Council and in which the tenant is a body in which I and/or my spouse or civil partner has a beneficial interest.**

**"Securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.**

**NOTE: The nominal value of shares is the face value of those shares (the value recorded on the share certificate)**
